#### Safe Home

Project Home Safe Home, the first safe space for Trans community members. The project provided relief from the daily prejudice, threats, harassment, attacks and discrimination the trans community faces. In the safe home project offered psychological and legal counseling, as well assistance from social workers. Also, informal educational training sessions were organized, covering a wide range of topics, including sexuality and safe sex. Various clubs offer courses, such as English language for beginners, physical and mental health, career and entrepreneurship development.

# Documentation of hate crime cases against trans people

The project aimed at enhancing transgender individuals' human rights protection in Armenia through fact-finding and evidence based advocacy. This project is going to collect first ever data exclusively focused on hate crimes, violence and discrimination faced by transgender community in Armenia, creating a comprehensive and consistent data collection mechanism in Armenian on hate crime cases and incidents documentation.

This project is designed to establish a hotline support of the victims of transphobic violence. Thanks to the project will be that for seven months, trans people in Armenia will be able to get legal counsellings and their rights are represented in the courts, police, or other state bodies.
